The physician assistant may not order any Schedule VI medications for this practice setting. _ Review of initial prescriptions or changes in medication (263 CMR 5.07(4)(a)7.). Example: All initial prescriptions and changes in medication written by the physician assistant shall be reviewed on a weekly basis.
