A regulation implementing federal firearms laws, 27 CFR § 478.11, defines curio or relic (C&R) firearms as those which are of special interest to collectors by reason of some quality other than is associated with firearms intended for sporting use or as offensive or defensive weapons. Liquor licenses are valid for a two year term. Supplier Permits are valid from the date approved through the following June 30. Temporary permits are valid for specific days. Non-beverage permits are for a one time use. All other permits are valid for one year.

Alcoholic Beverages Control Commission Apply for an Alcoholic Beverages Farmer Brewery License (ABCC) A Farmer Brewery license allows the holder to produce malt beverages and sell them at retail or at wholesale. Once an application is submitted via our eLicensing system, the typical turnaround time is 4 – 6 weeks.

An alcohol restriction on your MD license means that you are not allowed to drive if you've been drinking any amount of alcohol. Your MVA administrative hearing will look at any prior alcohol or drug-related criminal charges, at the points on your license or a combination of both in order to fully hold you accountable on the administrative side.
